TEST INFORMATION

The Test will commence at 9:00 AM. Running order will be posted on Entry Express and at the site.

Hunting License: State law requires participants and judges to have in their possession a valid hunting license from the state of residence or the state of North Carolina.

Birds: Chukars will be used at all tests.

Prizes: Standard AKC Rosette & Duck Bands for all qualifying scores.

Bitches in Season and injured dogs: The test committee must receive scratches prior to the beginning of the stake entered. Bitches in season cannot run and are not allowed on the grounds. A full refund will be available for bitches in season or injured dogs with letter from veterinarian. PCA will not pay any entry service fees.

Directions to the Hunt Test Sites:

PLEASE READ:

Use your GPS in conjunction with the following directions. You will wind up at the rest stop if you rely on your GPS exclusively. <https://maps.app.goo.gl/YgpFsG7A2hYN3KrJ6>

To Guns Up

Going East on I-40 take exit 174 Farmington.

Take right and first left onto 158. 3 miles and left at Rainbow Rd. Follow signs.

Going West on I-40 take Bermuda Run exit 180A.

Take right and next right at light onto 158. Go 3.4 miles and take right into Rainbow Rd. Follow signs.

To Annex:

Coming out of the Guns Up Headquarters.

Turn LEFT onto Rainbow Road. Go to the Stop Sign and turn RIGHT onto Route 158 West.

Go about 1 mile and turn RIGHT onto Pinebrook School Road.

At the next Stop Sign turn RIGHT, and take the second LEFT onto Sugar Creek Road.

Go to the end and you will see the property gate (which will be open) on the RIGHT. You will also see a Poodle Sign.

The road ends but you will see a sign that points to Cedar Brook Road on the left—just ignore.

Food: Lunch will be provided by Poodle Club of America on Friday, Saturday and Sunday. Please bring your own beverages.

Spooktacular Dinner Offered by PCA: On Saturday, October 31, 2026 there will be a dinner at the Guns Up Headquarters. Dogs and their humans are encouraged to wear costumes. - Please bring your own shade and water.
- Dogs must be on leash or confined when not running in test.
- Electronic collars are not permitted.
- Please keep cell phones on silent mode.

Please air/exercise your dogs away from the test location and those areas where there is likely to be foot traffic.

PICK UP after your dog. No un-entered dogs loose, please.

24 hours prior to the start of the test, only the judges and hunt test committee will be allowed at the test site.

REFUND POLICY:

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
